Then Corporation filed an appeal no. 97/98 before ADJ, Mathura who decided the appeal on 30.5.2005 against the Corporation. Now lInd appeal has been filed against judgement dt. 30.3.05 of ADJ, Mathura in Civil Appeal no. 97/98 whereby appeal of UPFC against decree of lower court was Rejected. Lower court has restrained UPFC from recovery and the same is pending for disposal. LEGAL OPINION: Party may be pursued for OTS.

The W.P. was allowed by the High Court on 19.12.97 and the entire proceedings in pursuance of the advertisement for sale of the unit dt. 21.8.86 U/S-29 of SFC's Act, 1951 dt. 21.8.86 was set aside. Corporation filed the Review Application which was rejected by the High Court on 13.1.2000. Corporation filed SLP in Supreme Court against the order of High Court dt. 19.12.97 which was dismissed on 17.8.2001. Only relief was given against the officers of the Corporation in respect of structure. Rest order of High Court was upheld. The then Law Officer, Sri N.K.K.Dixit noted on the file that High Court rejected the Review application mentioning as follows:- "UPFC may proceed U/S-29 of SFC's Act, 1951, the Court has issued, no injunction order". On this basis, Corporation issued fresh advertisement dt. 20.5.06 but High Court stayed the same as above vide order dt. 26.5.06.
